## **Important information regarding Short Format Events**

### **Please Read**

- Marathon attire (no shorts) is acceptable in both dressage and cones.
- Helmets must be worn during marathon and cones, and it is strongly suggested to wear helmets in the warm up arenas.
- Back Protectors must be worn on marathon.
- Veterinarians and Farrier are on call, not on site.
- Pneumatic Tires are permitted in ALL DIVISIONS.
- In the Beginner and Training divisions at Short Format Driving Events, verbal outside assistance is allowed in any competition phase, including Dressage. The groom or an outside assistant standing by the arena may call out the dressage test for Beginner and Training level classes without any penalty. Electronic communication equipment may also be used as long as only one earphone is used at a time while on the carriage.
- At Short Format Driving Events with a Modified Marathon, the whole course must be open for inspection by athletes at 12:00 pm (noon) the day before the scheduled start.
- At Short Format Driving Events, in the Modified Marathon, an athlete who fails to pass through a CTF in the published sequence and direction will incur 5 penalties per error (no elimination).

## **EXHIBITION FOR JUNIOR DRIVERS SOUTHERN SWING YOUTH CHAMPIONSHIP**

The Southern States Youth Championship will be open to drivers whose competition age for 2026 is between 10 and 18 for pony drivers or 12 and 18 for horse drivers. The championship will be held at the preliminary level, and competitors must have completed at least 1 competition or exhibition at the preliminary level or above within three years preceding the championship. These classes will follow all USEF rules for the preliminary level, and drive the USEF Preliminary 1 Dressage Test. All rules for marathon and cones shall apply, EXCEPT sharing of navigators, carriages, or harness is not permitted. There will be one class for pony drivers and one class for horse drivers. Awards will be presented at each event, with a Grand Champion and Reserve Grand Champion which will be presented at the Grand Oaks Winter Season Finale, March 26 – 29, 2026. In order to determine the Grand Champion and Reserve, points will be awarded for each event as follows: 6 points for 1<sup>st</sup> place, 5 for 2<sup>nd</sup> place, 4 for 3<sup>rd</sup> place, 3 for 4<sup>th</sup> place, 2 for 5<sup>th</sup> place and 1 for 6<sup>th</sup> place. Participating events are Grand Oaks Short Format, Florida Horse Park CDE, Spring Fling at the Grand Oaks CDE, Live Oak International and Grand Oaks Winter Season Finale.

**Entry Fee: \$250 for Short Format, \$100 Combined Test**

**Entry Fee Refund Policy: Full Refund prior to closing date, December 26, 2025, with a doctors' or vets' note. After closing date, refund at the organizers discretion.**

**Stall Fee: \$150 per stall, Friday - Sunday**

**Fee for additional days before or after stabling closes: \$25/day. All early arrivals or late departures must be approved by OC and are not guaranteed.**

**VERY IMPORTANT – PLEASE READ** Drivers and/or navigators may go round the marathon course a maximum of 2 times, if schedule allows. This also applies to sharing of carriage or harness. (DC 928.2.2) Competitors wishing to share navigators, drivers acting as navigators, carriages or harness must complete the Special Request for Sharing Form. Failure to complete the form will result in the request not being honored. This form must be turned in to the Scorer when competitor numbers are picked up at the show office.

**Veterinary and Health Requirements: Flu and Rhino within 6 months of show date and Coggins within 1 year of show date.**

**Awards, Championships and Prize Money (if applicable): Six Ribbons for each class.**

**Food available on grounds:**

**Dog Policy:** All dogs must be on a leash and under control at all times. Please do not take your dogs to the dressage ring or the cones ring during competition, or take your dog into the obstacles . Loose dogs, or dogs dragging a leash, will incur a fine of \$25 for the first offense, \$50 for the second, and so on and will increase by \$25 each time. You will need to come to the show office to collect and pay for your dog.


**Sharps Container: Competition Management may fine any individuals, including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.**

**Motorized Vechicle Statement: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.**



Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) deadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes
